In the month of March, District staff responded to 17 emergencies and completed 82 services and 13 manhole tickets. The back-log of manhole tickets decreased slightly for the month. Crews are still in the process of televising and reviewing upcoming CIP projects, and have started construction throughout the Rockford area. Crews also responded to 6 mainline backups.

Supporting Services Manager Cook stated staff placed an early order for one of the vehicles in this year's proposed budget due to the manufacturer's cut-off date for the State's purchasing program. This vehicle will replace the current vehicle used by the District's courier.

Business Manager Papke stated for the month ending March 31, 2015, the Income Statement shows user fee revenue 3% under budget month to date and 1% under budget year to date. Total revenue is equal to budget month to date and 1% over budget year to date. O&M expenses are 3% under budget year to date. The Income Statement shows \$3,242,125 net

operating income through March 31, 2015. The Statement of Cash Flows shows \$1,493,937 increase in cash for the 2014-2015 fiscal year. General Fund cash ended the month at \$19,443,039. The total number of full time positions as of March 31 was 109; total number of full time employees was 109.
