Operations Manager McFall provided the Board with copies of the report entitled, "Recommendations for Numeric Nutrient Criteria and Eutrophication Standards for Illinois Streams and Rivers," prepared by the Illinois Nutrient Science Advisory Committee. McFall reminded the Board that Rock River is classified as a Seventh Order Non-Wadeable River. McFall invited the Board to review the report with particular attention toward the sections applicable to the Rock River's classification. Standards recommended by the Advisory Committee for rivers the size of the Rock have two criteria: 1) Phosphorous should not exceed 1/10th mg/liter; and 2) Chlorophyll A should not exceed 25 micrograms/liter. Current level of Chlorophyll A in the Rock is unknown; however, studies conducted on phosphorous in the Rock indicate that the current level is two-and-one-half times the recommended amount.

Supporting Services Manager Reader provided status of activity regarding sewer main line cleaning, televising crews, pipe replacement, manhole ticket backlog breakdown and manhole restoration for the month of December.

Business Manager Black reported total revenue 3% over budget YTD. Operating expenses were 1% over budget YTD, and income statement reflects approximately \$4.7M net operating income through December 31, 2018. Cash increased approximately \$6.6M for the 2018-19 fiscal year. General fund cash total at the end of the month was \$29,269,777. Total number of authorized full-time positions is 116; 115 filled.
